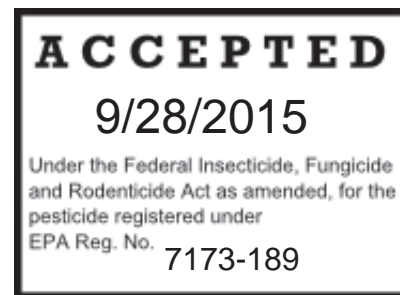

**For sewer applications,** securely attach one end of a wire to block of bait and the other end to a stationary structure such as the bottom step of manhole ladder or to a sewer grate, allowing just enough wire for bait to rest on manhole benching. If benching is not present, suspend bait a few inches above the high water line or place bait on a board supported by opposing steps of the ladder. Securing bait in this manner will minimize chance for removal by rats or water. Place at least one entire block of bait per manhole.

**Follow-up:** Replace contaminated or spoiled bait immediately.
