FIRST AID:

FLEA & TICK AREA TREATMENTS: Adjust nozzle to 'spray' and apply product to pet beds, pet resting areas, nearby cracks and crevices, and floors around pet activity. Thoroughly treat areas where pets and wild animals rest.

FLEA & TICK DIRECT PET TREATMENTS:

Do not apply treatment directly to eyes, open wounds or abrasions. Spray your pet with the nozzle about 8" to 12" away from the animal. Start by spraying the animal from the tail and working toward the torso. Make sure to treat the entire coat of the animal including legs, tail and underbody. Fluff the hair backward to help the spray penetrate through the coat and down to the skin. Do not spray in the face, eyes or genitals, or apply to pets under twelve (12) weeks old. Repeat as necessary. Pets may be treated indoors or outdoors. To help reduce the occurrence of fleas and ticks, this product is best if used year round. Sensitivities may occur after using any pet product. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, immediately consult a veterinarian. Consult a veterinarian before using this product on medicated, debilitated, aged, pregnant or nursing animals.
